
#### **Essential Question:**

From June 9-15, 2019, JACOB CUTHBERT, III was hand selected to participate in the National Boy Scouts of America Inaugural National Historian Summit. He spent 6 days and 7 nights at Philmont Training Center in Cimarron, New Mexico, days with 22 Scouts from around the country learning about Scouting history, how to archive history, and how to utilize technology in the preservation of history. At the end of the 6 days, the 22 Scouts received a Certificate of Completion as well as were given the designation of "Scouting Historian". Jacob is the first Scout in the Central Florida Council - Boy Scouts of America, the first Black Scout, and the first AME Scout to hold the designation of Scouting Historian. Jacob is currently serving his first term as Senior Patrol Leader (SPL) of his Boy Scout Troop (Troop #263 Lake Mary, Florida). The Christian Education Commission is proud of Master Jacob for achieving this very distinguished accomplishment.

#### "After Mass Shootings, Thoughts and Prayers Aren't Enough" by The Reverend Dr. Missouri McPhee



On an ordinary Saturday afternoon in El Paso, Texas, hundreds of parents and children were taking advantage of the school tax free holiday, preparing for the new school year, when bullets pierce the fallacy of what has become the nation's defacto policy on gun control, "thoughts and prayers". Just thirteen hours later, this act of violence would be repeated in Dayton, Ohio while people were enjoying a clear summer evening of dining and entertainment with friends. The evil that visited El Paso and Dayton marks the nation's 19<sup>th</sup> and 20<sup>th</sup> mass shooting in 2019. The combined death toll in El Paso and Dayton is at least 31, with many more sustaining physician and psychological injuries. Dayton police officials said officers responded in about 30 seconds, but the gunman had managed slaughtered nine innocent people and injured many more. Allow that fact to sit with you

for a moment. There have also been an increasing number of shootings and killings in local communities that have not garnered the attention of the media but are just as tragic and senseless. At this point, many of us would agree that the litany of "thoughts and prayers" are simply not enough! I know that sounds incredulous coming from a clergy person, but I stand by the sentiment. As a person of faith and the cloth, I wholeheartedly believe in the power of prayer. I stand in need of prayer daily. Prayer renews my strength and sometimes even my faith. Prayer keeps me in covenant with God and keeps me grounded. Not only do I engage in the practice of prayer and depend on prayer, I am also charged with teaching and preaching on prayer. As important as prayer is in my life, I am acutely aware that we are God's eyes, hands, feet, ears, and mouth. As my friend, Dr. Durrell Watkins, puts it, "...whatever we ask God to do for us, God must do through us". In other words, prayer without works is dead!

I love God, and, I have a healthy relationship with and respect for guns. Because I worship and serve God, I desire that all people within our borders should have the God-given and constitutional right to life, liberty, and the pursuit of happiness. Sadly, we have become a nation of gun worshipers that, as Bishop Adam Jefferson Richardson, Jr., the Senior Bishop of the African Methodist Episcopal Church, said, "hides behind the Second Amendment as if it were an amendment to the Decalogue". It makes little sense to be a nation of gun worshipers only to turn around and ask God to heal us from the hurt, harm, and destruction of the very thing we worship. We must realize that our prayers for the victims, survivors, and the families of gun violence will remain unanswered until we act.

So, then, "thoughts and prayers"? How is that working? Really? We simply must do better. The same God to whom these "thoughts and prayers" are directed requires better. I am, therefore, not only calling out this scourge upon our nation, but I am also calling up those elected by the people to serve ALL people; the President of the United States, members of Congress, state legislators, city and county officials; gun enthusiast and detractors alike; persons across every religious spectrum and political party and those who have none; everyday, ordinary citizens of every ethnicity, race, color, and creed to ban together to shift the reactive paradigm of "thoughts and prayers" to a more proactive one in the passage of common sense gun reform. It's more than a notion as there are varying competing interests involved. It will take compromise, cooperation and a willingness on the part of all concerned parties, but it can be done. This nation must somehow summon the courage to meet the challenge of this crisis head on. Surely, we can become the answer to this prayer.
